Re: Sewer Availability Charge Determination Requirement for Building Permits

Date: January 2016

To apply for a City of Osseo commercial building permit for

Commercial remodeling (if <u>any</u> building use change is occurring following
remodeling, including changing from a vacant to an occupied building);
Additions;
New construction;
Plumbing installation (including sinks, tubs, toilets, pedicure stations, and anything
else draining into the sewer system);
Any demolition work; or
Changes to indoor or outdoor seating arrangements;

you will need to supply a Determination Letter from Met Council regarding any potential associated Sewer Availability Charge (SAC) associated with the building project before the permit can be approved. You can apply for this Determination Letter yourself, or the City Planner can apply for you. Submitting your own application might lead to less time needed to receive a determination, because you will be able to directly respond to the Met Council's questions or requests for more information.

If you would like to submit your own application for determination, some suggestions for filling out the form are provided on page 2. The most current, up-to-date forms can be downloaded from the Met Council website: http://www.metrocouncil.org/Wastewater-Water/Funding-Finance/Rates-Charges/Sewer-Availability-Charge/SAC-Forms.aspx#Determination All projects will require Transmittal A, submitted in PDF form with required attachments. Additional Transmittals, affidavits, or attachments may be required for some uses, including but not limited to food service or manufacturing uses.

The SAC program will contact you via email if any parts of your application are incomplete or need to be corrected. If you have questions while filling out your own application, you may contact the City of Osseo Planning Department at 763-425-1454 or via email at nabts@ci.osseo.mn.us Please include your property address in your message when contacting city staff.

Forms should be submitted to SACprogram@metc.state.mn.us in electronic/PDF format. Please copy nabts@ci.osseo.mn.us on your email submission to inform city staff of your application. A final determination letter from Met Council must be received by the City before a City of Osseo building permit can be approved.

 - Incomplete and old version forms will be rejected
- Site Plan
- Architectural Floor Plans 1 set; Electronic floor plans are preferred (NO SPEC BOOKS)
 - Must be the <u>same</u> plan as submitted to the City for their review (Please copy <u>nabts@ci.osseo.mn.us</u> on your email submission to ensure the City of Osseo receives these plans.)
 - Scalable or with individual dimensions for <u>every</u> wall, room and space
 - Room Schedule, showing use for every room and space (if not specified on plan)
 - Seating layout (if restaurant, bar or theater) Include both indoor & outdoor seating
 - Plumbing fixture layout (if clinic, hospital or parking garage)
- 4. Demolition plans (if existing or remodel) 1 set include room schedule
- 5. SAC Affidavit, Reclaim, Transmittal-B and/or Transmittal-C forms (if applicable)
