Fight

On November 2nd at 4:30pm, Officer Heather Starry and Officer Todd Kintzi was dispatched to the 100th block of 3rd Ave on a report of a fight. Once the officers were on scene it appeared the parties were separated and no longer fighting. Officer Starry met with subject #1 who was visibly upset. The party stated she had an argument with her roommates about locking the deadbolt at 10:00pm so people could not enter the house. She felt what her roommates were doing was illegal and all renters should be provided a key. Subject #1 stated her roommate would not get out of her way so she pushed him and then he struck her in the face. Officer Kintzi met with Subject #2 who said he plan to evict Subject #1 but was told in order to do that he needed to go to court. The parties have a history of not getting along. The parties were advised to stay away from one another for the night.

Domestic

On November 10th at 6:06pm Officer Tony Mortinson was dispatched to a report of a domestic at the 300 block of 1st Ave. The caller was reporting his ex-girlfriend was trying to break down the door. Upon arrival Officer Mortinson observed a white female sitting on the ground, with her back against the door. Officer Mortinson immediately recognized the female from previous contacts. Officer Mortinson asked the female what happened tonight. She stated she has property inside her friends business and wanted it back so she could leave. When back up arrived officer Mortinson went inside to talk to the reporting party. He stated the female came over tonight demanding her property while banging and kicking the door. Officer Mortinson asked if the female could retrieve her property and stood by until it was retrieved and the female was picked up.

Accident

On November 4th at 9:35pm, Officer Tony Mortinson was dispatched to a report of an accident with unknown injuries. Dispatch advised per witness on scene, the vehicle had rolled over and the occupants of the vehicle exited and fled south on foot from the crash site. Upon arrival, Officer Mortinson noted a single vehicle in the area of the crash. The Vehicle was on the southeast corner of the intersection and it was on its roof with a large amount of debris around it. Officer Mortinson check the interior. after confirming there were not further occupants Officer Mortinson spoke with the witness. The witness stated while standing outside she heard some kind of grinding/ scratching coming from CO-81/Jefferson Hwy area. She looked closer and observed a white minivan losing control, before crashing and rolling over. As the witness went to call 911 she observed two white males earing neon/construction vellow shirts, exit the vehicle and run south down Jefferson hwy. As they ran past her one of the males called her a "dumb broad" for calling the police. Given the amount of concrete equipment in the vehicle and the damaged done to the vehicle itself, Officer Mortinson was concerned they may have injury. Officer Mortinson try to make contact with registered owner with not luck. The minivan was towed to Citywide and they were ordered not to release the van until an officer speaks with the owner.

Mutual Aid

On November 11th at 1:05am Officer Mortinson assisted Maple Grove PD on an unwanted person at McDonalds. Dispatch advised the male party was trying to get in the store and at one point urinated in the parking lot.

Threat

On November 8th at 6:00pm. Officer Grea Burstad responded the 100th block of 7th Ave SE on a threat complaint. When Officer Burstad arrived on scene he made contact with the reporting party. The reporting party stated her 6vr old son went outside to let their dog go to the bathroom. When he came back inside he told his mother their neighbor yelled at him about picking up the dog poop. The reporting party got upset and went outside and got into a verbal argument with their neighbor. The neighbor told the reporting party she was going to kick her in the stomach and she was seven month pregnant. The reporting party stated she was tired of being harassed by her neighbor. Officer Burstad then spoke to the suspect who was visibly upset. The suspect stated she was fed up with the reporting parties dog continuously pooping in their yard. She stated she politely told the reporting party's son to pick up the dog poop. The reporting party came out shortly after all worked up yelling at her about addressing the situation with her son. They got into a verbal argument. And at no time did she threaten to kick the reporting party in the belly. Officer Burstad advised all parties to stay away from each other and to call the police if anything happens in the future.

Disturbance

On November 25th at 12:47PM Officer Todd Kintzi was dispatched to a disturbance at Celtic Crossing. Dispatch reported a furniture delivery driver defecated on the 2nd floor trash shoot. Upon arrival Officer Kintzi met with building owner and the witness to retrieve a statement. Suspect denied the claim.
