


length. To apply you must live or work in Osseo, be 21 years of age and pass a criminal background/police contact check. There is no cost for this program.

# Just to Summarize

#### Theft

On February 1st at 10:17pm, Officer Tony Mortinson was dispatched to a theft report in progress located at the 600 block of 6th Ave NE. The reporting party advised there was a male and female in the dumpster, possibly stealing from it. Upon arrival Officer Mortinson located a vehicle parked directly in front of the dumpster. Officer Mortinson observed a female loading scrap metal into the vehicle and a male inside the dumpster. Officer Mortinson advised the couple to contact management of the apartment complex and get written permission to be on the property. Both agreed to leave and left without incident.

#### **Burglary Report**

On February 8th at 9:00am, Officer Greg Burstad took a residential burglary report at the front counter of the Police Department. The resident reported someone broke into his home between the hours of 12:00pm and 3:00pm. Minimal stuff was taken and reporting party believes he knows the suspect. Officers Burstad collected the information and submitted the report to Hennepin County for further investigation.

#### **Neighbor Trouble**

On February 20th at 4:30pm, Officer Michael Smith was dispatched to a complaint. The reporting party stated his neighbor was depositing chunks of broken ice on the street in front of his home. Officer Smith spoke to the neighbor who stated he was only trying to clear a path so the water would flow away from the front of his home. Officer Smith advised pushing water was fine, but asked as a good gesture to clean up the ice chunks in front of the neighbors house. The Neighbor agreed and continue pushing water. Officer Smith called RP and advised him of the conversation.

#### **Forgery Report**

The RP stated approximately 3 weeks ago some checks were taken from his residence. The RP contacted his bank and learned that one of the stolen checks was used in Osseo. Both parties refused to press charges. Officer Roberts decided due to the intoxication of the female to place her on a hold.
